About Course

Forensic Medicine and Toxicology is an amalgamation of multidimensional relationship of law and medicine encompassing forensic medicine, medical jurisprudence and toxicology altogether. Forensic Medicine deals with evidence when crimes against humans to find out the truth. For such purpose, doctors are called upon as witness, medical practitioner who has treated the patient or to provide expert opinion in a matter of science. Forensic Toxicology, on the other hand, deals with medical and legal aspects on the effects of chemicals, primarily poison, on human beings. The experts in forensic medicine and toxicology focus on identifying the effects of various poisons and chemical compounds such as alcohol and drugs on humans.

Program Syllabus

MODULE 1

FORENSIC MEDICINE AND COURT PROCEDURE

This module will help learners learn how to apply medical techniques in legal proceedings. Through this module, learners will be aware of the prominence of medical certification, medical reports and dying declarations.

MODULE 2

THANATOLOGY

This module will acquaint the learners with the meaning of thanatology, various modes of death, significance and moments of death, and immediate, early and late changes that occur after the demise of an individual. It will also focus on estimating the time since death after carefully examining a deceased body.

MODULE 3

PERSONAL IDENTIFICATION

This module will inform learners about the importance of Personal Identification and the minute details such as scars, moles, and tattoos, which help establish the identity of an unclaimed or unknown body. Information regarding establishing identity by personal items such as rosary beads, sacred thread, mangalsutras etc., will also be discussed.

MODULE 4

INJURIES (WOUNDS)

This module encompasses a detailed description of injuries. Learners will learn about the classification of injuries, including those caused by radiation, firearms and explosions, and fabricated and non-fabricated.

MODULE 5

FORENSIC TOXICOLOGY

This module will inform students regarding the significance of toxicology in Forensic Science, general aspects of poisoning, clinical features, autopsy appearances of various poisons, dispatch and preservation of viscera and their medico-legal significance.

MODULE 6

MEDICAL ETHICS

Under this module, students would be taught about the significance and distinction between medical certificates, birth certificates, death certificates and dying declarations.

MODULE 7
